

***WildReach* Terms and Conditions**

1. *WildReach* operates a 'no drugs or alcohol' policy.
2. In all classes, workshops, demonstrations and excursions conducted by *WildReach* all reasonable care will be taken to prevent serious injury and to minimize accidents.
3. The PARTICIPANT agrees that he/she is fully aware that Esoteric and Philosophical Plant-based Living, Earth-based living and Nature Awareness training, even under the safest conditions possible, may contain an element of risk and danger, and the PARTICIPANT hereby agrees to accept full responsibility and assume all risks, including those caused by Acts of God, of injury, death, and/or loss to his/her person and/or property knowingly and voluntarily.
4. The PARTICIPANT agrees to obey the rules and regulations *WildReach* puts in to effect to minimize these risks.
5. *WildReach* reserves the right to remove any PARTICIPANT from any class, workshop, demonstration or excursion, if the PARTICIPANT'S conduct is abusive or inappropriate.
6. The PARTICIPANT knowingly, voluntarily and irrevocably waives any and all past, present and/or future claims, demands and causes of action which the PARTICIPANT now has or may have in the future against all officers, employees, agents, instructors, assistant instructors, and/or other participants while on the premises of *WildReach* or premises hired to *WildReach* for the purposes of instruction, for any and all past, present, and / or future injuries, death, loss, including those caused by Acts of God, received while participating in activities conducted by *WildReach*, as a student, participant, spectator, and/ or visitor, or in any other manner or form, taking part in the exercises, practices, excursions, and/or demonstrations of said Esoteric and Philosophical Plant-based Living, Earth-based living and Nature Awareness training.
7. The PARTICIPANT certifies that she/he is physically, emotionally and mentally capable of participation in the said Esoteric and Philosophical Plant-based Living, Earth-based living and Nature Awareness training despite the rigors and possible dangers inherent in such an undertaking.
8. *WildReach* reserves the right to alter times, dates and content of courses if this becomes necessary and will endeavour to inform relevant parties as soon as practicable. In the event of a course cancellation, a full refund will be given. Alternatively, the course fee can be reallocated to another *WildReach* course.
9. The PARTICIPANT accepts that bookings must be made at least 2 weeks prior to the appropriate course commencement date, and must be accompanied by payment of the course fee in full, unless otherwise agreed by *WildReach* in writing.
10. The PARTICIPANT is aware that a booking cancellation by the PARTICIPANT, for any reason, will incur the forfeit of 50% of the course fee.
11. The course fee can be reallocated to another course one time only if the cancellation is 2 weeks prior to the course for which it was originally intended. Cancellation after 2 weeks prior to the commencement of the course for any reason, will incur the forfeit of 50% of the course fee.
